Regular rates apply between the hours of 8:00 A.M. – 3:15 P.M. An extended day charge is available to anyone needing care between 3:15 P.M. and 5:30 P.M. as noted below. Individual classes begin at 8:00 A.M. Children may check into the early room between 7:00 A.M. and 7:50 A.M. for a monthly charge.

**YEARLY REGISTRATION FEE: \$145 per family** to be paid at time of enrollment.

**ACTIVITY AND MATERIALS FEE: \$155 per student** to be paid in August

**\*\*The transition (5 yr.) class is designed for children who meet the age requirement for kindergarten; however, the parents have elected to give their child the gift of another year of pre-k for further social, emotional, and cognitive development. The transition class requires administration approval.**

**OVERTIME CHARGE:** Parents who leave children at Liberty Christian Academy after their scheduled pick-up time will be charged a **LATE FEE of \$10 for every five minutes they are late.** This will be added to your account and must be paid with the next scheduled tuition payment. We do ask that late pick-ups be kept to a minimum. If you are regularly late in picking up your child, it will be necessary for other arrangements to be made.

**SCHEDULE CHANGE FEE:** A schedule change fee of \$25.00 will be assessed for schedule change requests received after July 1, 2026, for each consecutive schedule change, the fee increases by \$25.00.

All families are required to establish a FACTS account. Families who pay monthly or quarterly are **required** to pay via FACTS by linking their bank account or credit card for automatic withdrawals (ACH). [www.factsmgt.com](http://www.factsmgt.com)  
There is a one-time, non-refundable FACTS participation fee to be drafted in July. The fee is based on payment plan chosen.
